### Ongoing Projects

#### **Subsequent SROI**

The next phase of the Compliance Initiative has begun. Earlier this year, the EDI QA Department sent out spreadsheets to all Claim Admins showing them a list of JCNs where the initial SROI has been received but no subsequent SROI was ever filed, including the QT transaction that is due 45 days at the end of each quarter. We gave each Claim Admin 60+ days to file the missing SROIs and now we have begun the formal process of issuing Letters and Orders for each individual claim where the subsequent SROI is still missing.

#### **Claim Admin Clean-up**

The Commission is cleaning-up all Claim Administrator FEIN's that are not valid per the Trading Partner documents on file. A spreadsheet with a list of claims was sent out to each Claim Administrator affected. We are still following up on these invalid FEINs to ensure the proper EDI transactions are filed reflecting a valid FEIN. This process will continue until all invalid Claim Admin FEINs are removed from our Claims Processing System.

#### **Insurance Carrier Clean-up**

The EDI QA Department is currently working with our Insurance Department to clean-up all invalid Insurance Carrier FEINs. This has been a long process and is still ongoing. For every JCN where a FEIN is provided and is invalid, according to our data, the Claim Administrator will receive an Invalid Insurer FEIN letter and is subject to a fine/penalty if a valid FEIN is not submitted to correct the EDI records.

### New Edit

#### **DN0006, Insurer FEIN, with Error Code 039, No Match on Database**

VWC will begin to verify DN0006, Insurer FEIN, against the VWC database to ensure the Insurer FEINs received are valid. To be specific, we are validating on insurer FEIN only, not for specific policy information/dates, employer data correlating to the insurer FEIN, etc... but only to see if the insurer FEIN listed on the transaction is a valid insurer FEIN for a carrier that is licensed and registered to do business in Virginia.

This means if you submit a transaction with an insurer FEIN that is not a valid FEIN the transaction will reject instead of accept. This is the same process that causes the generation of the Invalid Insurer FEIN letters today.
